**ROAD NAMING BY-LAW**

---

Being a by-law to affect certain road and street names, and changes in certain names in association with the Civic Addressing Program.

**WHEREAS** Section 210, Paragraph 111 of Municipal Act, R.S.O. 1990, provides that By-laws may be passed by the Councils of local municipalities to give names to or to change the names of highways, street and roads;

**AND WHEREAS** the Council of the Corporation of the Township of East Zorra-Tavistock deems it expedient to name and to change the names of certain streets and roads within the Township of East Zorra-Tavistock, in association with the Civic Addressing Project;

**NOW THEREFORE** the Council of the Township of East Zorra-Tavistock enacts as follows:

1. That all roads within and surrounding the Township of East Zorra-Tavistock shall be named in accordance with Schedule "A" attached hereto and forming part of this By-law.
2. That this By-law may be cited as the "ROAD NAMING BY-LAW".
3. That this By-law shall come into force and effect upon the date of final passing thereof and registration in the Land Registry Office for the County of Oxford.

AND WHEREAS the Council of the Corporation of the Township of East Zorra-Tavistock deems it necessary to name the said highway;

NOW THEREFORE THE COUNCIL OF THE TOWNSHIP OF EAST ZORRA-TAVISTOCK ENACTS AS FOLLOWS:

1. That the lands in the Township of East Zorra-Tavistock, formerly in the Village of Tavistock in the County of Oxford being Block 50, Plan 41M-130 is hereby dedicated as a public highway.
2. That the parcel of land described in Section 1 and dedicated as public highway is hereby named Frederick Court.
3. That the lands in the Township of East Zorra-Tavistock, formerly in the Village of Tavistock in the County of Oxford being Block 51, Plan 41M-130 is hereby dedicated as a public highway.
4. That the parcel of land described in Section 3 and dedicated as public highway is hereby named Bender Avenue.
5. That this by-law shall be registered in the appropriate Land Registry Office upon final passing thereof.

AND WHEREAS the Council of the Corporation of the Township of East Zorra-Tavistock deems it necessary to dedicate certain parcels of land as a public highway;


AND WHEREAS the Council of the Corporation of the Township of East Zorra-Tavistock deems it necessary to name the said highway;

2. That the parcel of land described in Section 1 and dedicated as public highway is hereby named "Maplewood Sideroad".
3. That this by-law shall be registered in the appropriate Land Registry Office upon final passing thereof.
