## **Outdoor Solid Fuel Combustion**

## **Appliances**

Respecting the rights of our neighbours and ensuring health and safety is an important and essential aspect of community living. To help keep our community a safe and enjoyable place to live, the Township has several by-laws that regulate and prohibit certain activities. These by-laws address such things as clean yards, property standards, noise, nuisances, animal control and parking violations to name a few. Council recently approved a by-law to regulate the use and location of Outdoor Solid Fuel Combustion Appliances. These appliances are commonly referred to as Outdoor Wood Furnaces.



By-law # 2009-18 prohibits the installation of these appliances in urban areas such as Villages, Rural Clusters, Subdivisions and Settlement Areas. It is believed there is considerable risk to the more densely populated areas of our Township as these appliances can produce substantial amounts of smoke which could be both a health hazard, as well as a nuisance for neighbours. Also, since these appliances can be used for heating water, they are often used year round, unlike a woodstove which tends to be in the winter only.

These appliances are permitted in rural and agricultural areas; however, only when they are located according to the provisions of the by-law and the proper permits obtained from the Township prior to installation. It is highly recommended that you review the provisions of the by-law and contact the Township before purchasing or installing one of these units. The complete by-law is available at the Township Office or can be accessed from the Township website at www.twp.ezt.on.ca. As well, you can contact the Township's Protective Services Coordinator, Fire Chief or Chief Building Official to discuss how this by-law may affect you.

This by-law does not apply to Outdoor Solid Fuel Combustion Appliances that were installed before the by-law was passed. The Township is asking anyone that has an Outdoor Solid Fuel Combustion Appliance currently installed to contact the Township, so that a record can be created and the Township Fire Department will have knowledge of where these appliances are currently located.

## If an Emergency Strikes....

Are you prepared if an emergency strikes? The following items should be a part of your Emergency Kit so that you and your family can care for yourselves for a minimum of **72 hours** in the event of an emergency:

- Flashlight and batteries
- Battery operated radio
- First Aid Kit
- Candles and matches
- Copies of important documents/identification for each person
- Food and bottled water
- Clothing and footwear (a change of clothing per person)
- Blankets or sleeping bags (one blanket or sleeping bag per person)
- Toilet paper and other personal hygiene supplies (soap, toothbrush, etc)
- Medication
- Extra cash
- Whistle (in case you need to attract someone's attention)
- Playing cards, games, reading material, colouring books, crayons etc.

# Fireworks Safety

If you plan to celebrate a special occasion with your own family fireworks show, please read the following tips. Family fireworks should only be used in clear areas away from structures and dry vegetation. Pay close attention to these safety guidelines.

- Purchase your fireworks from a reliable source
- Always read and follow the directions
- Persons using fireworks must be at least 18 years old
- Check the wind. Place fireworks in a bucket of sand and incline fireworks to go away from spectators (postpone fireworks if wind is strong)
- Always have water handy (garden hose or bucket)
- Never experiment or make your own fireworks
- Light only one firework at a time
- Never re-light a "dud" firework (wait 15-20 minutes then soak it in a bucket of water)

- Never give sparklers to children. Sparklers have been considered to be harmless fun however they burn extremely hot and can ignite clothing, resulting in severe burns and/or eye injuries. The sparkler wire remains very hot after burnout and should be soaked in a bucket of water before discarding.
- Dispose of fireworks properly by soaking them in water
- Never throw or point fireworks at other people
- Never set off fireworks during an open air burning ban
- Never carry fireworks in your pocket
- Never shoot fireworks in metal or glass containers
- The shooter should always wear eye protection and never have any part of their body over the firework
- Stay away from illegal explosives
- Support your Community and go to a local fireworks display

## **Controlled Burn Guidelines**

Most residents in the Township are aware of our "Controlled Burn" guidelines and we thank you for your cooperation in abiding by these rules. As a refresher, please review the following:

- If you are going to have a controlled burn, you must contact the Township office at 519-462-2697. You will be asked to give specific information such as date, location, time, etc. of your controlled burn. Permission can also be granted for weekend burns.
- Avoid starting any fires in dry situations and on windy days. Even the most carefully attended fire can quickly get out of control if conditions are right.
- Do not start any controlled burns past 4:00 p.m. Fires that burn into the evening and night are easily mistaken by others as fires burning out of control.
- If there is a day with poor air quality due to high outdoor temperatures and high humidex, permits for controlled burns will not be granted.
- Do not have large fires. If there is a lot of material to burn, split it into a series of smaller piles that can easily be managed.
- Respect your neighbours. Avoid having large quantities of smoke drift towards neighbouring dwellings as it is not only irritating, it can also be a fire hazard.
- No fires are allowed in villages unless they are in a burn or barbeque pit, or used for cooking purposes. Remember that even when these fires are out, these pits can still be very hot and easily lead to burns.
- Only the burning of wood products is allowed.
- If at all possible, keep an adequate source for extinguishing the fire close by at all times.

## Waste Management Items

### A couple of dates to mark on your calendar.....

Many of the Waste Management "Special Events" are now over for the spring season. These events have been a great success and listed below are a couple more events that will still take place.

White Goods Collection will take place May 30th 8:00 am - 1:00 pm at 944 James St. in Woodstock.

Large Article Collection will take place June 1st to the 5th.

- Collection is for residential and farm properties only.
- Regular household garbage is not part of the LAC
- Items can weigh no more than 45 kg (100 lbs)
- Set out must be on level ground. Material placed in ditches or swales will not be collected
- Items placed out in a garbage can/container, cardboard box or trailer/bin will NOT be collected
- All items must be to the curb/road by 7:00 am on the first day of collection.

For further information regarding acceptable/unacceptable items for either of these events, refer to your waste management calendars or visit our website to view the event.

Bag tags, blue boxes and composters are always available at the Township Office in Hickson. Costs are as follows:

Bag Tags \$1.25 each
Blue Boxes \$6.00 each
Composters \$20.00 each

# 9-1-1 Signs and Posts

Each property owner is responsible for the maintenance of the civic address (9-1-1) sign placed on their property. In the case of an emergency situation, it is extremely important that these signs are easily visible. If damage to the plate or the post has occurred, repairs must be done promptly and at the owners' expense. If this task is not completed, Township employees will do the work, with all costs incurred billed to the property owner.

# Congratulations to PW Manager - Dennis O'Neil


