

TAKE NOTICE that the Council of the Township of East Zorra-Tavistock passed By-law #2024-21 on the 5th day of June, 2024, and By-law #2024-25 (to amend By-law #2024-21) on the 19th day of June, 2024, both under Section 2(1) of the *Development Charges Act, 1997, as amended:*

AND TAKE NOTICE that any person or organization may appeal to the Ontario Land Tribunal (OLT) under section 14 of the Act, in respect of By-law #2024-21 by filing with the Clerk of the Township of East Zorra-Tavistock on or before the 15th day of July, 2024, a notice of appeal setting out the objection to the By-law, the reasons supporting the objection and must be accompanied by the prescribed fee.
